THANK YOU FOR SELECTING A Bösendorfer product. Bösendorfer products are designed and manufactured to provide a high level of defect-free performance. We are proud of the experience and craftsmanship that goes into each and every Bösendorfer product. We sell Bösendorfer products through a network of reputable, specially authorized dealers and are pleased to offer you, the Original Owner, the following Limited Warranty, which applies only to products that have been (1) directly purchased from our authorized dealers in the fifty states of the USA and District of Columbia (the "Warranted Area") and (2) used exclusively in the Warranted Area. We suggest that you read the Limited Warranty thoroughly, and invite you to contact your authorized Bösendorfer dealer or Bösendorfer Service Department if you have any questions.

This Warranty Covers The Listed Products Against **Defects In Materials Or Workmanship For 10 Years.**

Coverage: We will, at our option, repair or replace the product covered by this warranty if it becomes defective, malfunctions or otherwise fails to conform with this warranty under normal use and service during the term of this warranty, without charge for labor or materials. Such service includes in-home repairs for normal and customary repairs. Repairs may be performed using new or refurbished parts that meet or exceed our specifications for new parts. If we elect to replace the product, the replacement may be a reconditioned unit. This warranty does not cover (a) damage, deterioration or malfunction resulting from accident, negligence, misuse, abuse, improper installation or operation or failure to follow instructions according to the Owner's Manual for this product; any shipment of the product (claims must be presented to the carrier); repair or attempted repair by anyone other than the undersigned or an authorized Bösendorfer Service Center; (b) any unit which has been altered or on which the serial number has been defaced, modified or removed; (c) normal wear and any periodic maintenance; (d) deterioration due to perspiration. corrosive atmosphere or other external causes such as extremes in temperature or humidity; (e) damages related to lightning damage or acts of God; (f) the improper use of either certified or uncertified equipment; or (g) any non- Bösendorfer electronic or electro-mechanical devices added to the piano. Any evidence of alteration, erasing or forgery of proof-ofpurchase documents will cause this warranty to be void. This warranty covers only the Original Owner and is not transferable.

In Order to Obtain Warranty Service: Warranty service will only be provided for defective products within the Warranted Area. Bösendorfer Acoustic Pianos require in-home service. Contact your local authorized

Bösendorfer dealer who will advise you of the procedures to be followed. If this is not successful, contact us at the address or telephone number shown below. If you are uncertain as to whether a dealer has been authorized to sell Bösendorfer products, please contact the Bösendorfer Service Department at the number shown below. Product(s) must be accompanied by a detailed explanation of the problem(s) requiring service, together with the original or a machine reproduction of the bill of sale or other dated, proof-of-purchase document describing the product, as evidence of warranty coverage. Should any product submitted for warranty service be found ineligible, an estimate of repair cost will be furnished and the repair will be accomplished only if requested by you and upon receipt of payment or acceptable arrangement for payment.
